

Goalsetter and MasterCard HBCU Bootcamp Rules

1. **Eligibility:** The Goalsetter Financial Empowerment Bootcamp sweepstakes is open to legal residents of the United States who sign up at <https://goalsetter.co/financialemPOWERmentbootcamp/>. Entrants must be 18 years of age or older as of their date of entry in this promotion in order to qualify and must be current, matriculated students of HBCUs affiliated with the Atlanta University Center Consortium (AUCC-Spelman, Morehouse, Morehouse School of Medicine and Clark Atlanta). This sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited by law. Students of Wealth, Inc.'s employees, its subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, and directors (collectively the "Employees"), as well as members of an Employees' immediate family and/or those living in the same household of Employees are ineligible to participate in the Goalsetter Financial Empowerment Bootcamp sweepstakes .

2. **Sponsorship.** The sponsor is Students of Wealth, Inc. d/b/aGoalsetter ("Sponsor"), located at 266 Decatur Street, Brooklyn, NY 11233. Sponsor will conduct the Goalsetter Financial Empowerment Bootcamp sweepstakes substantially as described in these Official Rules.

3. **Agreement to Rules:** By entering this Sweepstakes, the Entrant ("You") agrees to abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserve the right to refuse, withdraw, or disqualify any entry at any time at the Sponsor's sole discretion. By entering this Sweepstakes, You represent and warrant that You are eligible to participate based on eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this Goalsetter Financial Empowerment Bootcamp sweepstakes .

4. **Goalsetter Financial Empowerment Bootcamp sweepstakes Entry Period:** This promotion begins on October 21, 2024 at 6:30pm ET and ends on November 22, 2024 at 11:59pm ET ("Entry Period"). To be eligible for the [Sweepstakes or Contest], entries must be received within the specified Entry Period.

5. **How to Enter:** Eligible entrants can enter the Goalsetter Financial Empowerment Bootcamp sweepstakes by:

- **Early Signers: Being** among the first 300 Eligible entrants to take a pre-survey, complete 5 of the 10 modules, complete a post-survey, download the Goalsetter App, open a Goalsetter savings account and pass identity verification. These winners will receive \$100, deposited into their Goalsetter savings account.
- **Scholars:** 3 Eligible entrants who complete the above steps will be randomly selected to win \$2500 each.

As a participant, your entry must fully meet all Sweepstakes requirements, as specified in the Official Rules, in order to be eligible to win a prize. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified at the Sponsor's sole discretion. The Scholars Winners will be selected by a random drawing under the supervision of the Sponsor. The Sponsor is not responsible for nor shall have no liability for any Winner's failure to receive notices due to email security settings that may cause notifications to be marked as spam or junk email. Nor shall be Sponsor be liable for the Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the prize within 90 days from the time the award notification was sent, 2) is found ineligible, or 3) does not complete and return an executed declaration and release within the specified timeframe, the prize may be forfeited and an alternate Winner may be selected.
